MEDIA POLICY

If you are media, a podcaster, writer or blogger, the Roundtable is considered "off the record". Please speak to the organizers (and your subjects) before posting on social media about the content discussed. If any unauthorized recording/posting is discovered you will be asked to remove the posting and delete the content from your recording device. At the Satoshi Roundtable we work hard to find a balance between transparency and the privacy necessary to facilitate open frank discussion. Recording is only allowed with prior approval from the organizers.

Please keep streaming and video/ audio to the dedicated section of the hotel property.

CODE OF CONDUCT

Pitching is strictly prohibited unless specifically requested by another attendee. Repeated violations will result in removal from the event. The Satoshi Roundtable is a retreat, not your typical conference. As such, we ask you to observe the Code of Conduct 24/7. Be considerate, respectful, and collaborative. Refrain from demeaning, discriminatory, or harassing behavior and speech. Be mindful of your surroundings, and your fellow participants. Alert security if you notice a dangerous situation, or someone in distress.

The Roundtable enforces a strict code of conduct aligned with the laws of the host country. Organizers reserve the right to remove attendees for unethical behavior or engaging in illegal activities. Violators will be escorted from the venue.

NON-DISCRIMINATION AND ANTI-HARASSMENT POLICY
